

## **The Noise Emission in the Environment by Equipment for use Outdoors Regulations 2001: UK Notified Bodies**

Under the Noise Emission in the Environment by Equipment for use Outdoors Regulations 2001<sup>1</sup>, Notified Bodies shall be appointed to carry out or supervise the various conformity assessment functions. These procedures are necessary to demonstrate conformity with the requirements of the Noise emission in the environment by equipment for use outdoors Directive (2000/14/EC)<sup>2</sup> and to ensure that the quality of production of equipment for use outdoors remains constant and in accordance with those requirements. Only products listed in Schedule 1 of the Regulations (Article 12 of the Directive) require the involvement of a Notified Body.

This booklet lists the Notified Bodies appointed by the Secretary of State for Trade and Industry, under Regulation 14 and notified to the European Commission. Details of the identification number issued by the European Commission to each Notified Body are also shown.

Throughout this booklet, the functions that each Notified Body has been appointed to undertake are referred to by the appropriate Annex within the Directive. These are:

- Annex VI: Internal control of production with assessment of technical documentation and periodical checking (Schedule 9 of the Regulations);
- Annex VII: Unit verification (Schedule 10 of the Regulations); and
- Annex VIII: Full quality assurance (Schedule 11 of the Regulations).
